The National Pandemic touched everyone, causing pain and heartache far and wide. We as a nation can never fully express the gratitude owed to frontline workers who gave so much throughout the pandemic. Some of those who were tragically lost were the brave men and women who work every day in one of America's most difficult and dangerous jobs. The Correctional Officers and other front-line staff who have made the ultimate sacrifice have gone largely unrecognized.

Over the past 15 months we have suffered the loss of over 260 Correctional Officers, Supervisors and Essential Personnel to COVID-19 Line of Duty Deaths. We have done our best to verify those losses and memorialize the names of those lost. Please accept our apologies if we missed anyone or mispronounce any of their names during the Vigil.
